## **Reporting Suite cont...**

NuVu Reporting Suite allows you unlimited options in formatting any data that you have generated:

- Edit font, font size and colour
- Add lines, boxes, or any shape that will enhance the aesthetics
- Add a company logo or any relevant graphic to the report
- Represent results through many different graphs, charts and even barcodes
- Conditional formatting (i.e. if value is less than zero, show in RED)

Once the report is designed, the user is presented with a variety of options of what to do with it (including a preview function):

- Standard print to any printer within the network
- E-mail blast as a PDF or HTML file
- Fax
- Save as XML, Excel/CSV, PDF for later use

These options have the effect of automating and digitalising many aspects of your business, where previously there was a dependency on printing. In many cases, this will have a direct reduction to the operating costs of your business.

**POLLING** – Using unique data already present within your current reports, NuVu can be set to look at the print queue, or a specific folder on the network, to intercept reports and implement your new design.
